

#### CONSTITUTION

#### **Preamble**

WHEREAS, having been organized in 1849, we the Churches of the Judson Association of Baptists, being convinced that an association of churches can more effectively perpetuate the cause of Christ, do adopt the following Articles as written bond of fellowship, cooperative function, and administrative purpose.

#### Article I - Name

This Association shall be called the Judson Baptist Association.

#### **Article II - Mission**

The mission of this Association shall be to further the cause of Christ by enabling the churches in worship, ministry, evangelism, fellowship, and discipleship; and to provide staff leadership and volunteer services in order to fulfill this mission...

#### **Article III - Membership**

A member church shall be a Baptist church, cooperating with the Judson Baptist Association, the Tennessee Baptist Convention, and the Southern Baptist Convention. Member churches agree with the general intent of The Baptist Faith and Message.

A church may become a member of the Association by petitioning the Association in writing at any time, but at least ninety (90) days prior to the annual meeting. Petitioning churches shall be under the watch care of the Association until voted upon at the next annual meeting.

A church may voluntarily withdraw from the Association at any time by notifying the Association in writing. However, such withdrawal shall not become final until voted upon by either the Executive Board or Messengers at the Annual Meeting.

#### **Article IV - Authority**

The Association shall abstain from internal problems of a participating church except upon request of the involved congregation, and shall exercise no ecclesiastical authority over any church.

#### **Article V - Annual Meeting**

The Association shall meet annually in October, the time, date, and place to be set by the messengers in the annual meeting.

#### **Article VI - Parliamentary Procedure**

Robert's Rules of Order (latest revised edition) shall be recognized as the authority in parliamentary procedures.

#### **Article VII - Messengers**

The voting body at the Annual Meeting of the Association shall be comprised of messengers duly chosen by the churches.

Every Church in this Association shall be entitled to a minimum of three (3) messengers. A church is entitled to an additional messenger for every twenty-five (25) members, or fraction thereof, exceeding fifty (50) members. No church shall be entitled to more than ten (10) messengers.

#### **Article VIII - Officers**

#### **Section A:**

- 1. The officers of this Association shall be a Moderator, Vice-Moderator, Clerk, Treasurer, Trustees, and Directors of Associational Departments, all of whom shall be elected annually, except as otherwise specified, and shall continue in office until a successor is elected.
- 2. Annually elected Officers shall be recognized and take office just prior to adjournment of the business session of the Annual Meeting.
- 3. The Nominating Committee shall nominate officers at the Annual Meeting, and an opportunity for nominations from the floor shall be given.
- 4. Interim Officers may be appointed as deemed necessary by the Executive Board.
- 5. All Officers are expected to attend the Annual Meeting, the quarterly Officers Meetings, and the Executive Board Meetings unless providentially hindered.

#### **Section B:**

#### 1. Trustees

The Association shall have three (3) trustees, each serving for three (3) years on a rotation basis, with one (1) new member being elected each year. The duty of the trustees shall be to hold in trust all properties of the Judson Baptist Association, and to transact all legal matters pertaining thereto, subject to the direction of the Association.

#### 2. Moderator

#### The Duties Of The Moderator Are:

- a. To preside over the Annual Meeting, called meetings, and the Executive Board Meetings:
- b. To encourage fellowship and mutual care among the churches of the Association;
- c. To appoint members of special committees as the need may arise, and as by the Association;
- d. To serve as an ex-officio member of all committees.

#### 3. Vice-Moderator

#### The Duties Of The Vice-Moderator Are:

- a. To serve as parliamentarian at the Annual Meeting of the Association, called meetings, and Executive Board Meetings;
- b. To preside over the Annual Meeting, called meetings, and the Executive Board Meetings in the absence of the Moderator;
- c. To become Moderator in the event the Moderator should become unable to serve;

d. To serve as Alternate Treasurer in the event the Treasurer is absent or unable to fulfill his or her duties for a period of thirty (30) days or more.

#### 4. Clerk

#### The Duties Of The Clerk Are:

- a. To serve as recorder for the Annual Meeting of the Association and the Executive Board Meetings;
- b. To prepare and publish the Minutes of the Annual Meeting and the Executive Board Meetings.

#### 5. Treasurer

#### The Duties of the Treasurer Are:

- a. To submit a financial report at the Annual Meeting and the Executive Board Meetings;
- b. To approve records of all money received and disbursed;
- c. To account for and disburse the Associational funds. The Associational Treasury shall not be used by anyone other than the Treasurer;
- d. To be chairperson of the Budget Committee.

#### 6. Sunday School Director

It shall be the duty of the Sunday School Director to offer encouragement and assistance in establishing and/or promoting the Sunday School of all churches the Association.

#### 7. Discipleship Training Director

It shall be the duty of the Discipleship Training Director to encourage, promote, or assist in establishing a Discipleship Training program in all churches in the Association.

#### 8. Music Director

#### The Duties of the Music Director Are:

- a. To encourage and/or assist with the music program of all churches in the Association;
- b. To plan, attend, and participate in all Associational Singings.

#### 9. Brotherhood Director

It shall be the duty of the Brotherhood Director to offer encouragement in establishing and promoting the Brotherhood organization in all churches of the Association.

#### 10. WMU Director

#### The Duties of the WMU Director Are:

- a. To offer encouragement and assistance in establishing or promoting the WMU Organization in all churches of the Association;
- b. To promote and encourage missions and giving to mission offerings;
- c. To attend state and regional WMU functions as often as is practical and feasible;
- d. To serve on the Missions Committee.

#### 11. Youth Director

#### The Duties of the Youth Director Are:

- a. To assist and encourage all churches of the Association in developing a continuing program of youth training and active participation in evangelism, soul winning, and church leadership;
- b. To serve on the Evangelism Committee.

#### 12. Evangelism Director

#### The Duties of the Evangelism Director Are:

- a. To lead the Association in formulating plans for the annual Associational Evangelism Conference and Associational Revival;
- b. To lead the Association to address the priority of evangelism;
- c. To develop programs and functions to involve the Associational evangelistic activity and training;
- d. To serve as chairperson of the Evangelism Committee.

#### 13. Stewardship Director

#### The Duties of the Stewardship Director Are:

- a. To encourage and assist all churches in the Association in developing an ongoing stewardship program;
- b. To plan and direct stewardship commitments to the Associational Mission;
- c. To serve as a member of the Budget Committee.

#### 14. VBS Director

#### The Duties of the VBS Director Are:

- a. To assist and challenge churches to start, improve and enlarge all areas of VBS through planning, training, administration, consultation, program interpretation, and cooperative projects;
- b. To serve as a member of the Evangelism Committee.

#### 15. Media-Library Director

It shall be the duty of the Media-Library Director to maintain historical records of the Association.

#### 16. Association Volunteer Mission Director Job Description

A director of volunteer missions is responsible for gathering and coordinating volunteers for various mission projects. If the volunteers are providing their assistance overseas, the director is responsible for ensuring that the volunteers have the correct travel-related materials such as visas, passports and shots. The director is also responsible for engaging volunteers, managing and communicating with the churches and other mission organizations about opportunities that they may want to get involved with.

#### **Article IX - Annual Report**

It shall be the responsibility of each church to complete the Annual Church Profile (ACP) provided by the Associational Clerk. All ACPs are due and should be returned to the Clerk by the September First of each year, and must in any event be returned not later than the first day of the Annual Meeting.

#### **Article X - Executive Board**

The Executive Board of the Association shall consist of all Officers of the Association, the Chairperson of all standing committees, one (1) elected representative from each church, and all church pastors in the Association.

The Executive Board shall meet quarterly. Additionally, the Moderator may call the Executive Board into session at any time upon notice to all Board Members, stating the purpose of the meeting.

Executive Board shall have the authority to transact any necessary Association business arising between sessions, and shall make an annual report to the Association.

The Associational Moderator, Vice-Moderator, Clerk, and Treasurer shall be the Officers of the Executive Board. The Moderator or Vice-Moderator shall preside during all Board meetings, and the Clerk shall keep a written record of all proceedings.

#### **Article XI - Discipline**

Disciplinary action may be taken by the Association for the following reasons:

- 1. Neglect of a church to send messengers to the Annual Meeting for two (2) consecutive years;
- 2. Neglect of a church to submit the Annual Church Profile for two (2) consecutive years;
- 3. Neglect of a church to financially support the Association for two (2) consecutive years;
- 4. A gross doctrinal error, as determined by the Association;
- 5. The Moderator, the Director of Missions, and/or a committee appointed for that purpose should seek reconciliation with the church.

#### **Article XII - Amendments**

Any proposal for amending the Constitution must be presented in writing to the Association during the business session of the annual meeting. A period of one year must be given for publication before consideration by the Association and a two-thirds (2/3) vote of messengers present shall be necessary to make such changes.

#### **Article XIII-Staff**

#### **Director of Missions**

The Director of Missions shall give general supervision and direction to the total program of the Judson Baptist Association, for the purpose of achieving the objectives as stated in Article II. He shall be called and employed for an indefinite period of time by vote of the Executive Board and/or the Messengers of the Annual Meeting, upon recommendation of the Personnel Search Committee. A detailed job description for the Director of Missions is attached. (Job description not made available to Clerk)

#### **Article XIV - Committees**

The following committees, including chairpersons, shall be nominated by the Nominating Committee at the Annual Meeting, and an opportunity for nominations from the floor shall be given. Each committee member shall serve one year beginning at the conclusion of the Annual Meeting.

#### 1. Annual Meeting Committee

This committee shall consist of at least four (4) members, and have the following responsibilities:

- a. To propose an order of business for the Annual Meeting;
- b. To propose place, dates and speakers for the Annual Meeting at least two years in advance;
- c. To publicize the complete order of business for the Annual Meetings to the churches in the Association at least thirty (30) days in advance;
- d. In cooperation with the Moderator and other program personnel, to arrange for all facilities needed for the Annual Meetings;
- e. To receive invitations from churches and suggestions for program emphasis and personnel for future sessions.

#### 2. Budget Committee

This committee shall consist of at least four (4) members, and shall have the following responsibilities:

- a. To work with the Treasurer, who shall serve as chairperson, in developing and recommending an overall financial development plan;
- b. To work with the Treasurer in developing and recommending an Associational budget based on the Constitutional Objectives stated in Article II;
- c. To make recommendations concerning proposed expenditures not included in the budget;
- d. To review expenditures periodically and recommend budget adjustments if needed.

#### 3. Evangelism Committee

The committee shall consist of at least four (4) members, and shall have the following responsibilities:

- a. To promote the cause of Christ by encouraging all churches to be evangelistic in outreach and in ministering to the lost.
- b. To plan and conduct evangelistic rallies, revivals, and conferences annually.

#### 4. Missions Committee

This committee shall consist of at least four (4) members, and shall have the following responsibilities:

- a. To lead the Association to address the priority of missions in the United States and around the world:
- b. To assist the Director of Missions in the mission work of the Association.

#### 5. Nominating Committee

This committee shall consist of at least four (4) members, and shall have the following responsibilities:

- a. To select, interview, enlist, and recommend Associational officers, standing committee members, and chairpersons;
- b. To present workers to the Association at the Annual Meeting for election;
- c. To assist Associational program leaders in discovering and enlisting qualified persons to fill positions in their respective organizations;
- d. To make recommendations for filling vacancies in positions that may occur during the year.

#### 166<sup>th</sup> Annual Meeting of the Judson Baptist Association Minutes from October 17, 2015

The Judson Baptist Association Annual Meeting was held on October 17, 2015 at the Mt Zion Baptist Church on 7625 Union Valley Road, Fairview, Tennessee 37026.

Vice Moderator, Bro Cecil Gilliland, called the meeting to order, asking Bro Felix Gomez to open in prayer before proceeding with the rest of the official meeting.

Bro Jerry Harrison, lead the congregation in a hymn, "Are You Washed In The Blood" accompanied by Sis Marian Pendergrass on the piano.

Associational Clerk, Sis Joyce Davidson called the roll; out of the 14 churches in the Association 11 churches were represented; 42 messengers signed in, approximately 60 in attendance.

Bro Gray started his report by asking prayer for Bro Leo Hagewood and Bro Mark Profitt. Bro Gray asked the visiting representatives from the different entities to speak first:

- A. Bro Campbell spoke for the TN Baptist Children's Home, stated that the Home is a non-profit and does not accept any state funds. He spoke on Matthew 18:10 about rescuing children. The Baptist Children's Home is supported by the Churches and Individuals, or job is to rescue the children and to keep the Children's Home going.
- B. Bro Kenny Cooper, Treasurer of the TN Baptist Adults Home. The Golden Offering, Father's Day Offering and the Co-Op Program supports the Home of 300 plus adults a year, plus other programs. We have 4 different campuses, 3 independent and 1 nursing home. We hold a Camp for 2 weeks for special friend's campers for age's teens thru 80's at Camp Linden each year. Bro Kenny closed with a passage of scripture with Paul talking to the Galatians.
- C. Lana Rose, TBC representative, talked about the 90<sup>th</sup> anniversary of the Co-Op Program, and what this program entails. She also mentioned at this time that the Golden State Offering stays in Tennessee, and also that the Association will get back 10% of this offering. She works with the church secretaries, works with the Pastors wives and also the Bi-Vocational Retreat, she mentioned that this retreat really helps the wives of the Pastors.

Bro Gray emphasized that the month of October was "Pastor's Appreciation", and that the Bi-Vocational Pastors Retreat was coming up and that if a Pastor needed help to go help would be provided, he also talked about the missions reported located on page 3 of the Book of Reports.

During this time Ms Marian Pendergrass spoke about the "WMU Banquet" that would be held at New Hope Baptist, and the meal would be catered and would cost \$14.00 per person, they are really excited about that night. Ms Barbara Petty of FBC of Bon Aqua, spoke about "National Women's Day of Prayer" to be held on Nov 2<sup>nd</sup>, 6:30pm at FBC of Bon Aqua.

Bro Wayne Etheridge spoke about the "Sunday School Leadership Seminar" Connecting People to God's Word: A life-changing Sunday School, that is to be held at the Pumona Baptist Church, 6:30pm.in Pumona where Bro Joe Shannon is Pastor.

Bro Allen Cochran spoke about Joint "M" Night Discipleship Rally 2015 to be held on Monday night, October 26, 2015 at 7:00pm, at the FBC of McEwen.

Bro Gray spoke about the R.G. Lee class that is to be held at Sylvia BC, 6:00pm, Course Description: Approaches to Moral Decision Making.

Bro Gray also announced that Bro Joe would be over at the Judson Association Building on Tuesday and Thursday's from 8:00am to 3:30pm or 4:00pm, and also announced that Bro Aaron Terlecki was the new Pastor at Burns.

Bro Cecil asked for any other Departmental or Committee Reports:

- A. Bro Wilson Spencer presented the Memorial for the Deceased from the different Churches that is found on page 4 of the Book of Reports.
- B. Bro Joe Shannon mentioned that the Monthly News Letter is changing, it will also include the Stewart and Truett Association and he also talked about "VBS". Bro Joe talked about the upcoming trip to Ecuador, Nov 2<sup>nd</sup> 10<sup>th</sup>, the church in Ecuador is self-sufficient, the church is having 60 to 80 in attendance. Bro Joe told of the Pastor from Florida, that got in touch with him about a lady that lives in Dickson, family was worried about her, when Bro Joe went to the ladies home he was surprised when she answered the door, to find that she had tattoos and piercing all over her face. But that did not make any difference she invited him in and he shared God's Word with her and she accepted Christ.
- C. Ms Mary Donegan gave the Annual Meeting Committee Report, which you will find on Page 5 of the Book of Reports.
- D. Ms Lucille McFarlin gave the Treasurer/Budget Committee Report which you will find on pages 7 & 8 of the Book of Reports. Ms Lucille mentioned that God has really blessed the Churches financially, and then talked about the Proposed Monthly Budget for 2015-2016 for the Judson Link-up to be raised to \$1,600.00, no questions and no recommendations.
- E. Ms Lucille gave the Nominating Report, page 6 of the Book of Reports, the only changes for the new year is as follows: Bro Cecil Gilliland as the Moderator, and Bro Aaron Terlecki as the Vice Moderator.

Bro Cecil asked about Old Business, no Old Business, New Business was the dedication of the meeting in honor of Bro Cletus Tidwell. Bro Andrew Allen asked if a love offering could be taken up for Mt Zion, everyone agreed. Bro Cecil mentioned that we could take up a love offering and also mentioned that it would be nice if all Churches in the Association would take up a love offering for Mt. Zion.

Bro Cecil asked if the ushers would come forward and take up the WMU Endowment offering which would be in honor of Mrs Barbara Petty, endowment offering was \$247.00.

Bro Jerry Harrison led congregational hymn "I'll Fly Away" accompanied by Sis Marian Pendergrass on the piano.

Bro Wilson Spencer, our speaker for this special occasion spoke on St John 9:1-5, but before he started on his message he told us that he would be baptizing 4 at his church this afternoon and also possibility of a trip to the Holy Land with Bro Gray. Bro Wilson read verses 1:5, with emphasis on Verses 4 & 5, our eyes have to be open. Wrong assumption can hinder our work for the Lorde, Wrong perspective can hinder our work for the Lord. We have to be the Light of the

World, nothing should hinder the works of the Lord. Misappropriation can hinder the work for the Lord. Bro Wilson also spoke form Proverbs 10:5 and St John 4:34-36.

Bro Jerry Harrison led the invitational hymn "Just As I am", and accompanied on the piano by Ms Marian Pendergrass.

Love offering of approximately \$1,256.00 was taken up for Mt Zion, the Church was so appreciated.

Bro Wayne Etheridge read verse from 1 Corinthians 16:13 then led the dismissal prayer, blessing for the noon meal and benediction.





#### **Tennessee Baptist Adult Homes**

Some years have more milestones than others. The 2014-2015 fiscal year has certainly been one of those years for your Tennessee Baptist Adult Homes (TBAH). This year witnessed the twentieth year that TBAH has conducted Special Friends Camps (the TBC conducted them for the thirteen years prior). There were a total of 260 campers during the two weeks of camp, one at Carson Springs and one at Linden Valley. Assisting those campers were 75 staffers, most of them high school and college students from Tennessee Baptist churches. As always, the campers had a wonderful time. The love and help offered them by the staff is such a wonderful witness to the love of Christ. These camps are made possible through funding provided by the Golden Offering for Tennessee Missions. Without this support, we could not make the camps affordable for most of the campers.

Baptist Health Care Center in Lenoir City had wonderful state survey results recently with no deficiencies in nursing care and only three building issues needing attention. We are nearing the end of the R.A.R.E. campaign solicitation for funds to renovate the rooms in the nursing home. Churches and individuals have up to five years to contribute their pledged amounts. We hope to begin some renovation work soon. Also in process is the conversion of the assisted living wing into skilled care with therapy services. These changes should make the facility both more inviting and accessible to people with a greater variety of care needs.

The group homes for adults with intellectual disabilities are thriving with happy residents and a quality staff. One sad note during the year was the death of a resident at Brooks House for women after a long illness. Even though hospice care was involved, the house manager wanted to care for the resident at the home so she could die in a familiar place surrounded by her friends there. This kind of care is only possible because of the prayerful support of those who give to underwrite the cost. The Father's Day Offering funds are used almost exclusively for the support of TBAH's six group homes. To date this year, Tennessee Baptists have given \$334,150 to the offering. It appears that the goal of \$350,000 will be reached by the end of this fiscal year October 31st!

There have been a number of key employees reaching retirement since the report last year: Cindy Wilmoth, Administrator at Baptist Health Care Center; Hudson Clark, Manager of Deer Lake Retirement Community; and, Jim Highland, Director of Development. We are thankful for their many years of good service. We have welcomed Melissa Franklin as Administrator at Baptist Health Care Center and Ann Davenport as Manager at Deer Lake. Both of these are members of Tennessee Baptist churches and have a lot of experience in their respective management areas. Due to the recentness of Jim Highland's retirement, a new development person has not yet been selected. And, in the spring I announced my retirement effective at the end of this year. It has been a deeply gratifying experience to have been a part of the TBAH ministry for the past twenty years. I am thankful for the board members and staff colleagues I have been privileged to work with. Likewise, I have had the wonderful support of TBC leadership and staff who have been helpful in every way that they could. And, last but certainly not least, I am grateful for the prayers, financial support, especially through the Cooperative Program, and the encouragement of so many Tennessee Baptists all across the state. For you all I give thanks to God.

#### Tennessee Baptist Children's Homes, Inc.

2015 has been an exciting year in the 124 year history of the Tennessee Baptist Children's Homes. It has been a year of transition, a year of growth, a year of accomplishment, and a year of achievement.

In the fall of last year, the President/Treasurer Search Committee of the TBCH Board of Trustees recommended that Greg McCoy, pastor of First Baptist Church, Portland, be named the new leader of the TBCH statewide ministry. Bro. Greg joined our staff on November 1st and is near completion of his 14 months of learning the details of the day to day operations of the ministry.

Dr. Bryant Millsaps will officially retire from active ministry at TBCH on December 31<sup>st</sup>, 2015. Having assumed the position of President/Treasurer on January 1<sup>st</sup>, 2000 and having served two years prior to that as Assistant to the President, Dr. Millsaps, upon his retirement, will have served the Lord and Tennessee Baptists for 18 years.

Over this past year, TBCH has experienced growth in a number of ways. First, we have seen a gradual increase in the number of certified foster homes across the state. Second, with the expansion of available homes, we have seen more and more children being place in TBCH Foster Care. The Denise and George Shinn Foster Care Program is expanding at an impressive rate. Where our original age cap on children coming into our foster care program was originally 10 years old, the Tennessee Department of Children's Services has exercised its option to increase that age cap to 12 years of age. This will allow TBCH Foster Care homes to take in more sibling groups and keep brothers and sisters together.

One of TBCH's Core Values is Excellence. We believe that we are called by God to excellence in every aspect of our ministry "as unto the Lord" (Col. 3:23). For over a year, TBCH has been diligently working toward accreditation through the Council on Accreditation (COA). COA is an accrediting body that sets best practice standards for many types of organizations. TBCH's programs (residential and foster care), financial management, maintenance of all records (both personnel and children in care), quality assurance, and engagement of both internal and external stakeholders have been reviewed for compliance with their standards. This has been a rewarding process that has affirmed most of our preexisting operational standards and provided us with valuable input for improving our ministry. At the writing of this report, it is anticipated that TBCH will be an accredited member of COA by the time the convention meets in November.

Finally, the closing of the 14/15 fiscal year on October 31st, is expected to be one of the most financially stable years in recent history. This is due to three things:

- (1) The faithful provision of the Lord through His people;
- (2) The dedicated service of the Trustees and Senior Staff to monitor our expenses and responsibly manage our assets to bring financial stability to the day to day operations of TBCH, and;
- (3) The increasing number of evangelicals who have responded to TBCH's entrance into foster care therefore providing a biblically based, Christ-centered vehicle to participate in caring for children who are at risk.

THANK YOU TENNESSEE BAPTISTS for your faithfulness to pray and give so that the love of Christ can be shown to children and families all across Tennessee whose lives are in varying stages of crisis.

#### Tennessee Woman's Missionary Union Annual Report September 1, 2014 through August 31, 2015

"All For You – Surrender, Sacrifice, Serve" was the 2014-15 emphasis for Woman's Missionary Union based on Mark 8:34.

Vickie Anderson was unanimously elected as Executive Director-Treasurer by the TN WMU Executive Board November 1, 2014. She assumed the role January 1, 2015. The Executive Director-Treasurer Search Committee included Chair Phyllis Cobb, Springfield; Vice-Chair Shelby Lord, Lenoir City; Frank Green, Sparta; Rhonda Poore, Kenton; and Delores Coffey, Morristown.

The Tennessee WMU Missionary House, officially named "Mary's House", is finished – built, furnished and decorated! Six years ago Tennessee Woman's Missionary Union took on the God sized task to build a missionary house on the grounds of the Missions Mobilization Center in Mt. Juliet to commemorate our 125<sup>th</sup> anniversary and to provide a place for larger missionary families to reside and rest during their stateside assignments. Together we raised over \$200,000 for building and furnishing the house and another \$100,000 to establish an endowment for the future care of the house. Over \$60,000 worth of services and items were also donated to build and furnish the house. We are very grateful for these gifts, as well as, for the many people who poured countless hours into making this dream become a reality. We broke ground on April 6, 2013; dedicated the house on November 1, 2015; held an open house on August 1, 2016; and will welcome the first missionary family in September 2016. To God be ALL the Glory!

Missions Get-Together and Connection were held on March 20-22, 2015 at the Gatlinburg Convention Center with a total attendance of 1,634. Jean Roberson, from Birmingham, Alabama was the keynote speaker for Missions Get-Together. Rachel Lovingood, from Hendersonville was the keynote speaker for Connection. The annual offering totaled \$9,035.03 with 90% designated to the 2013-14 Golden Offering for Tennessee Missions; 10% benefited Tennessee N Touch Endowment at the WMU Foundation. Through the event ministry project, participants brought items to support Baptist Collegiate Ministries across Tennessee by giving: \$4,464.83 in cash, checks and gift cards; 3,707 Pop Tarts/snack bars; 262 rolls of toilet paper; 458 other paper products; 340 office supplies; 366 packages of drink mix/tea; plus much more!

Vickie Anderson was installed as Executive Director-Treasurer during the Tennessee WMU annual session on March 21, 2015 at the Gatlinburg Convention Center. Bobby Turner from First Baptist Church, Lenoir City was elected for her fourth year as President. Other officers elected include: Recording Secretary, Susan Kellough from Newbern; and Vice Presidents: Kathy Neely, Greenback; Lynda Ryan, Hendersonville; and Linda Pratt, Somerville.

The 2014-15 State Acteens Advisory Panelists were Susanna Clouse, Caney Fork Baptist Church, Cookeville; Hannah Schussler, Ebenezer Baptist Church, Greenbrier; and Emily Bartlett, Caney Fork Baptist Church, Cookeville.

Currently there are 17 Christian Women's Job Corps and 8 Christian Men's Job Corps sites in Tennessee. The new state coordinator is Janice Carter from Jasper. Baptist Nursing Fellowship is currently without leadership and did not meet in 2014-15. There are fifteen nationally trained literacy missions workshop leaders who are equipping church and associational leaders to serve through literacy ministries: English as a second language, adult reading and writing, and tutoring children and youth.

Two TN WMU prayer-walking teams went to Italy in cooperation with the convention partnership. Colleen Richardson, from Livingston, led a team in October, 2014. A second team led by Ann Davenport and Carolyn Outland, both from Murfreesboro, went to Italy in August, 2015.

The goal for the 2014-15 Golden Offering for Tennessee Missions was \$1,650,000. The theme for the 2014 Week of Prayer for State Missions was "Wake Up!" based on Romans 13:11. As of July 31, the total amount given to the 2014-15 GOTM was \$1,595,802. The GOTM giving year is September 1 – August 31.

#### **Baptist & Reflector**

The year 2015 has been a milestone for the *Baptist & Reflector*, the official newsjournal of the Tennessee Baptist Convention. This year the *Baptist and Reflector* is celebrating its 180<sup>th</sup> anniversary. It began in 1835 as *THE BAPTIST*. The paper is one of the oldest newspapers in the Southern Baptist Convention.

The paper is mailed to nearly 25,000 homes 26 weeks a year, reaching a potential readership of about 63,000 people.

In addition, the B&R has become one of the top two most viewed pages on the Tennessee Baptist Convention's website at <a href="www.tnbaptist.org">www.tnbaptist.org</a>. With the shift to a biweekly format, the goal is to increase the B&R's web presence. A new dedicated website for the B&R will be launched this year. It will replace the "virtual edition" and will make it much easier to share articles and columns. It will be "user friendly." The website will have new material added regularly and an update will be sent weekly to those who are used to receiving the "virtual edition." The virtual edition will no longer be published once the new website is ready for use.

The goal of the paper is to "tell the story of Tennessee Baptists" through news, feature stories and photographs. As in the past, the paper this year placed a major emphasis on what Tennessee Baptists are doing to reach the world for Christ by focusing on stories related to missions and evangelism. This year the paper has focused on timely topics for Tennessee Baptists and our churches. Issues have focused on addictions, issues related to same-sex marriage, and the Supreme Court decision in June and others.

The *Baptist and Reflector* continued to utilize social media tools in 2015 such as Twitter. Editor Lonnie Wilkey regularly writes a blog that provides information for Tennessee Baptists between print issues. The paper also will introduce a Facebook page this year.

The staff monitors trends that could affect Tennessee Baptists and prints those stories to keep readers informed. In addition, opinions, both from the editor and others, are printed and are intended to make readers think, reflect, and act.

The paper continually seeks to enlist new subscribers and will be offering a simplified subscription plan in the near future. #### **IMB Report Fall 2015**

**GOD IS WORTHY of the worship of all people,** yet billions have yet to hear of Him. That's why we go. That's why we send to the growing global cities and the hard-to-access places. We go into a dark and broken world to share the only hope: the gospel of Jesus Christ.

IMB has been helping churches to participate in God's global mission since 1845. In the 21st century, we are equipping churches to send in new and creative ways. IMB exists to empower limitless missionary teams to make disciples and multiply churches among unreached peoples for the glory of God.

Redeemed and made new in Christ, we have a missionary identity that compels us to take the gospel even to difficult places and hard-to-reach peoples. In a beautiful partnership, IMB helps churches send ordinary Christians, empowered by God's extraordinary presence, to make disciples and multiply churches among unreached people for the glory of God.

Toward this end, last year Southern Baptists gave \$94.7 million through the Cooperative Program (\$94,736,418.32) and \$153 million (\$153,002,394.13) through the Lottie Moon Christmas Offering® for International Missions, supporting more than 4,700 missionaries sent out by Southern Baptist churches through IMB.



In addition, Southern Baptists gave \$6.6 million (\$6,556,271.02) for hunger relief and development ministries around the world.

Together, these gifts enabled IMB missionaries to report:

- 274,888 people professing faith in Christ
- 190,957 new believers expressing their faith through baptism
- 13,824 new churches planted

And yet today, more than 6,000 people groups and 2.8 billion people have never heard the good news of the gospel and currently don't have access to this good news. God is sending church planters, professionals, students, retirees and others to major global cities, where millions of unreached people flock to seek better lives. We can give them hope in Christ.

As IMB mobilizes Christians and churches to join God's mission through evangelism, Bible translation, disaster relief, sustainable development and more, it is with one goal in mind: to make disciples and multiply churches in fulfillment of Christ's commission.

The local church is the agent that God has promised to use for accomplishing the Great Commission," said IMB President David Platt.
