Constitution

ARTICLE I - NAME

This Association shall be called the Truett Association of Missionary Baptist.

ARTICLE II - PURPOSE

1. To foster fellowship among the churches cooperating with the Association.
2. To assist the churches in strengthening their programs of enlistment, evangelism, teaching, and training.
3. To encourage churches in the establishment of missions and new churches.
4. To promote these programs of the Tennessee Baptist Convention and the Southern Baptist Convention as it may deem proper.

ARTICLE III - MEMBERSHIP

The Membership of this Association shall be composed of messengers elected by the churches with the Truett Association on the following basis.

1. Each church, regardless of size, may have three (3) messengers.
2. Each church may have one (1) additional messenger for each fifty (50) members or fraction thereof over 100 members.
3. No church may have over ten (10) messengers.
4. All pastors of the churches, officers of the Association and members of the standing committees shall be members of this Association. Churches may be admitted to membership in this Association by a two-thirds majority vote after a petitionary letter has been received by the Credentials Committee. and upon said committee's recommendation.

ARTICLE IV - OFFICERS

The officers of this Association shall be Moderator, Assistant Moderator, Clerk and Treasurer and any other officers that the Association may deem necessary in order to perform the work which needs to be done. The officers shall be elected on the first day of the Association's Annual Meeting, and their tour of duty will begin at the close of the Annual Session. The Moderator may not be eligible for election if he has served two or any part of two terms until at least a year has passed.

ARTICLE V - AUTHORITY

The Association claims no jurisdiction over the churches, and shall exercise no authority over them; however, it shall be the duty of the Association to offer fraternal council to any church in need of the same, upon their request. The Association will reserve the right to refuse to recognize messengers from any church which persists in disorderly practices.

ARTICLE VI - EXECUTIVE COMMITTEE

1. This Association shall have an Executive Board composed of the regular officers of the Association, and other elected officers, Pastors and Chairman of the Standing Committees, along with two elected laymen from each church.
2. This committee shall meet on the fourth Monday night, in October, January, April, July and August. (July shall be the planning meeting). November, January, March, May and June be given to promoting Sunday School, Discipleship Training, Brotherhood, W.M.U. and Stewardship. Only urgent business will be introduced at an emphasis meeting.

ARTICLE VII - PARLIAMENTARY PROCEDURE

1. The By-Laws may be added or the Constitution altered by a two-thirds majority of those present at any regular meeting of the Association. Said recommendations shall be presented to the Executive Committee at the meeting prior to the annual meeting.
2. Robert's Rule of Order shall be the governing procedure.

BY-LAWS

- I. One-half of all messengers attending the Association meeting shall constitute a quorum.
- II. Brethren not messengers of the Association and visiting Brethren invited to sit with the Association may be privileged to discuss but not the right to vote.
- III. The Nominating Committee shall make recommendations for all officers and committee members of Standing Committee.
- IV. The Moderator shall appoint any committees not otherwise provided for.
- V. The Moderator shall have the same privilege, as other members, provided he vacate the chair. While occupying the chair, he may vote only in case of a tie. These rules shall apply to the Assistant Moderator while he is occupying the chair.
- VI. The Association year closes August 31st. Church letters shall be in hand of Clerk by September 15th.

- VII. The Annual Association shall meet Thursday evening after the last Sunday in September.
- VIII. The Executive Board shall be the governing body of the Association between Annual Meetings and shall meet on the fourth Monday night of October, January, April and August with the Moderator given the authority to call special meetings of the Executive Board when needed, upon 7 days advance notice.
- IX. An Associational Calendar of events for the coming year shall be prepared and printed in minutes each year.
- X. All resolutions and reports shall be presented in writing, signed by person offering such report and shall become a part of the permanent record.
- XI. The Clerk and Treasurer shall be paid for services rendered by the amount set by the Budget and Finance Committee.
- XII. The following committees compose the standing committees of this Association
- 1) Promotion - All elected officers compose this committee and the Vice Moderator will serve as Chairman.
 - 2) Missions - This committee shall work with the Director of Missions in various projects in the Association, and shall be composed of five members.
 - 3) Budget and Finance - This committee will have two Pastors, Associational Treasurer and two other laymen.
 - 4) Program - This committee shall have three members, including Associational Clerk.
 - 5) Nominating - This committee shall nominate all officers, standing committees and fill any vacancies, which may occur. This committee shall be composed of five members.
 - 6) Credentials and Doctrine - This committee shall examine Credentials of new Churches and make the necessary recommendation after examination, and also counsel with any church when requested.
- Each committee shall make a report of the work accomplished and of the plans for the future to the Executive Committee at the four (4) Executive Board Committee meetings. Report of Committees to be made to the Executive Committee at the meeting prior to the Annual Associational Meeting.
- XIII. The Moderator shall be ex officio members of all committees, standing or special.
- XIV. The By-Laws may be amended or changed at any time by a majority vote of those present - Executive Committee or Annual Association.

**WORKING AGREEMENT
BETWEEN TRUETT ASSOCIATION OF MISSIONARY BAPTIST AND ASSOCIATION DIRECTOR OF MISSIONS**

- I. POSITION TITLE:** Association Director of Missions will be the official title, hereinafter called DOM of the Truett Association of Missionary Baptist, hereinafter called the Association.
- II. BASIC FUNCTION:** Provide leadership in the work of the Association in the interest of strengthening the cooperative Baptist witness throughout the area.
- III. QUALIFICATIONS:**
- 1) Personal dedication and consistent Christian living.
 - 2) A sense of call to mission service.
 - 3) Adequate educational preparation, preferably college and seminary training or the equivalent in experience and other training.
 - 4) Thorough knowledge of the work of a Southern Baptist Church.
 - 5) Knowledge of Association work from personal experience as a DOM or as a participating pastor or other Church leader.
 - 6) Reasonable knowledge of Southern Baptist denominational life and willingness to continue to learn.
 - 7) Ability to relate effectively to rural and small town Pastors and Churches.
- IV. RESPONSIBILITIES:**
- 4) Work with Association leaders and committees in planning and conducting activities designed to strengthen the churches according to their needs, and to maintain effective mission ministries in the area.
 - 5) Lead in planning and coordination of a calendar of Association activities to be presented each year to the annual meeting business session and printed in the minutes of the annual meeting as already provided for the By-Law number of the By-Laws Association.
 - 6) Lead in training Association organizational leaders and committees.
 - 7) Publish monthly a newsletter of the Association. The newsletter should contain news of interest, highlights of Executive Board action, treasurer's report, upcoming dates of Association activities, and other information and inspiration at the discretion of the DOM.
 - 8) Provide counsel and help as reasonably requested by Pastors and Churches.

- 9) Assist in stewardship development in order to undergird the work of the Association and encourage growth in the support of mission causes through the Cooperative Program.
- 10) Assist in maintaining a Biblical evangelism concern in the Association.
- 11) Serve as denomination contact person in the Association relaying quickly news of interest to churches by use of monthly newsletter, reports to the Executive Board, or other communication as considered appropriate by the DOM.
- 12) A report of DOM activities and concerns will be made at each Executive Board meeting and an annual report will be presented by the DOM to the Association Clerk for inclusion in the "Book of Reports" for the annual meeting. The DOM will report regularly to the Missions Department of the TBC.
- 13) The DOM will demonstrate true commitment to the purpose of Association as prescribed in Article II, "Purpose", of the Constitution of the Association.

V. CALL:

- 1) The call and employment of the DOM be by approval of the Association Executive Board. The Association Executive Board. The Association Missions Committee will serve as search committee when a vacancy of the position occurs and will recommend a nominee for the position to the Executive board.
- 2) The call of the DOM of the Association is a indefinite one. The position of DOM himself, or the Executive Board. The DOM will give the Executive Board thirty (30) days notice if resignation is desired; and the Executive Board will give the DOM sixty (60) days notice if the DOM's resignation is called for.
- 3) The amount of salary and allowances will be worked out and presented for approval annually. It is suggested that the Missions committee and the Budget and Finance committee work together when negotiating a pay package with the DOM.
- 4) Four (4) weeks per year will be allowed, off the field, for revivals, world mission conferences and other such activities. Consideration of the Association calendar is suggested when such activities are scheduled by the DOM.
- 5) The DOM will be allowed two weeks paid vacation each year, with three weeks after five years of service. Vacation time cannot accumulate one year to the next, and payment will not be made for time not taken. Consideration of Association activities is suggested in the scheduling of vacation time by the DOM.
- 6) One day of sick leave with pay shall accumulate for each month of service to a total of ninety (90) days. Sick leave is intended for use by the DOM in case of his illness or that of his immediate family that requires his attention or assistance, including funerals. Sick leave will be forfeited at the time of the DOM's resignation, or dismissal. The Association will not make payment for accumulated sick leave.
- 7) The DOM shall be entitled to receive and keep honorariums from revivals and from supply preaching when the church normally would provide and honorarium.
- 8) The work schedule may vary from week to week as need arises in the Association and Churches.
- 9) Due to the size of the Association and the rural setting of most of our Churches this agreement does not propose to regulate how many times the DOM can supply the pulpit, occasionally or successively in each Church, however, it is not intended that the DOM will serve any Church as interim Pastor, but rather assist as requested by the Church in securing pulpit supply so that DOM time and attention can be equitably shared with other churches and Association responsibilities. It is suggested that the DOM compile and maintain a current list of licensed and ordained ministers, and lay speaker in the Association that are available for supply work.
- 10) The employment of the DOM shall be considered full time.
- 11) The Association treasurer will be the payroll officer and the DOM will report to the treasurer when vacation time and sick leave is used, so a record of leave may be maintained.

VI. SUPERVISION:

- 1) The DOM will be basically "self supervised".
- 2) The Missions committee will serve as an advisory committee to the DOM in all matters pertaining to terms of employment and this agreement.
- 3) The Association Executive Board will direct the Missions committee and the DOM, and the Association will be the final authority pertaining to all matters of the agreement

VII. MISCELLANEOUS:

- 1) All other working agreements which have been made between this Association and other DOM's are null and void.
- 2) This agreement shall be recorded annually in the Association minutes and may be amended as necessary by the Executive Board or in the annual meetings. Two months notice should be given before amendments are made. The DOM will be informed in writing of any proposed amendments two months before action is taken.

Truett Association Annual Meeting-October 1, 2015

The 65th Annual Session of the Truett Baptist Association opened with music led by the Praise Team of Sylvia Baptist Church, this year's host church.

Bro. William Gray, Director of Missions, led a devotional from Psalms 85:6. He stated that in order to see our churches grow and continue to see souls saved we must have Revival, Restoration & Recommitment. He challenged us to always have joy in all we say and do. He closed by saying that October 4 is Soul-Winning Commitment Day and encouraged the churches to participate.

The meeting was called to order with a welcome & prayer by Bro. Ken Brown, Associate Pastor of Sylvia.

Tennessee Baptist Convention Representative Ms. Lana Rose spoke about the Cooperative Program's 90th anniversary and how those funds are being spent. She presented a video from Dr. Randy Davis, Executive Director of TBC. Dr. Davis spoke on how churches can help reach the 5 objectives of the convention that were established at the 2014 TBC annual meeting.

Bro. Kenny Cooper, Adult Homes Representative, spoke of the Adult Homes across the state and the 350 adults being serviced throughout Tennessee. (Full report on page 2 of the Book of Reports)

Mrs. Glee Smith, Associational Clerk, presented for approval the summary of the year's Executive Board meetings & Digest of Church Letters. (Pages 10 & 11, Book of Reports) Motion to accept was made by Bro. Reece Cochran, seconded by Bro. David Devers. Motion passed.

Bro. Neal Westerman, Chairman of Nominating Committee, presented for approval from the Nominating Committee the proposed officers & committees for 2015-16. (page 12, Book of Reports) Motion to accept was made by Bro. Dwayne Smith, seconded by Bro. Reece Cochran. Motion passed.

Bro. Neal Westerman, LINK-UP Advisory Committee Chairman, spoke on behalf of the Advisory Committee and presented the LINK-UP Report between Judson Baptist Association, Stewart Baptist Association and Truett Baptist Association. (page 13, Book of Reports) He also explained that the purpose of the LINK-UP, as stated in the Covenant Agreement between the Associations (page 14, Book of Reports) is still accomplishing the goals as they were set up. These goals include sharing staff & expenses and holding joint training for VBS, Missions groups, Sunday School, Evangelism & others.

Bro. Neal Westerman presented on behalf of the Advisory Council the LINK-UP Treasurer's Report (page 16, Book of Reports) and the LINK-UP Proposed Budget. (page 17, Book of Reports) Bro. Neal explained line item #6 in the amount of \$2,500.00 is money that will be set aside to build funds for once Bro. Gray retires and the state funding changes. Bro. Dwayne Smith made a motion to accept reports as presented, seconded by Bro. Reece Cochran. Motion passed.

Miscellaneous Business – None

Mrs. Carmen Westerman presented the Treasurer's Report. (page 18, Book of Reports) She stated that the totals were slightly off from the reports from the churches because of when she cut off the budget year and when the churches sent in their checks. Mrs. Carmen asked for Bro. David Devers to come

3. Bro. Joe has accepted the position as Pastor of Pomona Baptist Church and will be working more often at the Judson Associational Office.
4. Bro. Joe congratulated Oak Grove Baptist Church on their Missions giving for the year, which was 32% of their annual budget.

Bro. Dwayne Smith and Glee Smith and the Children's VBS Mission Team from Slayden Baptist Church gave a report on their mission trip to Carlisle Baptist Church in Stewart Association. Four souls were saved.

Mrs. Carmen Westerman gave the WMU report that included that the Golden Offering for Tennessee Missions for 2016 will be emphasized for this year. They are planning to help build up the missions organizations including RA's.

Mrs. Liane Keaton offered condolences to the churches that have lost loved ones during the past year. The names of those remembered is on page 23 in the Book of Reports. Bro. Frank Daughterty led in prayer for these families.

Congregational Singing & Special Music was led by the Praise Team from Sylvia Baptist Church.

The evening's message was by Bro. Ken Brown. The scripture passage used was 1 Kings 21:1-3. His message was on how Christians can defeat secularism in America today. He stated that we as Christians must nurture the nation and stand firm on God's Word no matter what. He said that no man, court or government has the right to make laws that are against God's Word.

Motion to adjourn was made by Bro. Neal Westerman, seconded by Bro. Reece Cochran. Motion passed.

Bro. William Gray announced M-Night on October 26 at McEwen First Baptist. Bro. Gray dismissed in prayer.

Tennessee Baptist Adult Homes

Some years have more milestones than others. The 2014-2015 fiscal year has certainly been one of those years for your Tennessee Baptist Adult Homes (TBAH). This year witnessed the twentieth year that TBAH has conducted Special Friends Camps (the TBC conducted them for the thirteen years prior). There were a total of 260 campers during the two weeks of camp, one at Carson Springs and one at Linden Valley. Assisting those campers were 75 staffers, most of them high school and college students from Tennessee Baptist churches. As always, the campers had a wonderful time. The love and help offered them by the staff is such a wonderful witness to the love of Christ. These camps are made possible through funding provided by the Golden Offering for Tennessee Missions. Without this support, we could not make the camps affordable for most of the campers.

Baptist Health Care Center in Lenoir City had wonderful state survey results recently with no deficiencies in nursing care and only three building issues needing attention. We are nearing the end of the R.A.R.E. campaign solicitation for funds to renovate the rooms in the nursing home. Churches and individuals have up to five years to contribute their pledged amounts. We hope to begin some renovation work soon. Also in process is the conversion of the assisted living wing into skilled care with therapy services. These changes should make the facility both more inviting and accessible to people with a greater variety of care needs.

The group homes for adults with intellectual disabilities are thriving with happy residents and a quality staff. One sad note during the year was the death of a resident at Brooks House for women after a long illness. Even though hospice care was involved, the house manager wanted to care for the resident at the home so she could die in a familiar place surrounded by her friends there. This kind of care is only possible because of the prayerful support of those who give to underwrite the cost. The Father's Day Offering funds are used almost exclusively for the support of TBAH's six group homes. To date this year, Tennessee Baptists have given \$334,150 to the offering. It appears that the goal of \$350,000 will be reached by the end of this fiscal year October 31st!

There have been a number of key employees reaching retirement since the report last year: Cindy Wilmoth, Administrator at Baptist Health Care Center; Hudson Clark, Manager of Deer Lake Retirement Community; and, Jim Highland, Director of Development. We are thankful for their many years of good service. We have welcomed Melissa Franklin as Administrator at Baptist Health Care Center and Ann Davenport as Manager at Deer Lake. Both of these are members of Tennessee Baptist churches and have a lot of experience in their respective management areas. Due to the recentness of Jim Highland's retirement, a new development person has not yet been selected. And, in the spring I announced my retirement effective at the end of this year. It has been a deeply gratifying experience to have been a part of the TBAH ministry for the past twenty years. I am thankful for the board members and staff colleagues I have been privileged to work with. Likewise, I have had the wonderful support of TBC leadership and staff who have been helpful in every way that they could. And, last but certainly not least, I am grateful for the prayers, financial support, especially through the Cooperative Program, and the encouragement of so many Tennessee Baptists all across the state. For you all I give thanks to God.

Tennessee Baptist Children's Homes, Inc.

2015 has been an exciting year in the 124 year history of the Tennessee Baptist Children's Homes. It has been a year of transition, a year of growth, a year of accomplishment, and a year of achievement.

In the fall of last year, the President/Treasurer Search Committee of the TBCH Board of Trustees recommended that Greg McCoy, pastor of First Baptist Church, Portland, be named the new leader of the TBCH statewide ministry. Bro. Greg joined our staff on November 1st and is near completion of his 14 months of learning the details of the day to day operations of the ministry.

Dr. Bryant Millsaps will officially retire from active ministry at TBCH on December 31st, 2015. Having assumed the position of President/Treasurer on January 1st, 2000 and having served two years prior to that as Assistant to the President, Dr. Millsaps, upon his retirement, will have served the Lord and Tennessee Baptists for 18 years.

Over this past year, TBCH has experienced growth in a number of ways. First, we have seen a gradual increase in the number of certified foster homes across the state. Second, with the expansion of available homes, we have seen more and more children being placed in TBCH Foster Care. The Denise and George Shinn Foster Care Program is expanding at an impressive rate. Where our original age cap on children coming into our foster care program was originally 10 years old, the Tennessee Department of Children's Services has exercised its option to increase that age cap to 12 years of age. This will allow TBCH Foster Care homes to take in more sibling groups and keep brothers and sisters together.

One of TBCH's Core Values is Excellence. We believe that we are called by God to excellence in every aspect of our ministry "as unto the Lord" (*Col. 3:23*). For over a year, TBCH has been diligently working toward accreditation through the Council on Accreditation (COA). COA is an accrediting body that sets best practice standards for many types of organizations. TBCH's programs (residential and foster care), financial management, maintenance of all records (both personnel and children in care), quality assurance, and engagement of both internal and external stakeholders have been reviewed for compliance with their standards. This has been a rewarding process that has affirmed most of our preexisting operational standards and provided us with valuable input for improving our ministry. At the writing of this report, it is anticipated that TBCH will be an accredited member of COA by the time the convention meets in November.

Finally, the closing of the 14/15 fiscal year on October 31st, is expected to be one of the most financially stable years in recent history. This is due to three things:

- (1) The faithful provision of the Lord through His people;
- (2) The dedicated service of the Trustees and Senior Staff to monitor our expenses and responsibly manage our assets to bring financial stability to the day to day operations of TBCH, and;
- (3) The increasing number of evangelicals who have responded to TBCH's entrance into foster care therefore providing a biblically based, Christ-centered vehicle to participate in caring for children who are at risk.

THANK YOU TENNESSEE BAPTISTS for your faithfulness to pray and give so that the love of Christ can be shown to children and families all across Tennessee whose lives are in varying stages of crisis.

Tennessee Woman's Missionary Union Annual Report September 1, 2014 through August 31, 2015

"All For You – Surrender, Sacrifice, Serve" was the 2014-15 emphasis for Woman's Missionary Union based on Mark 8:34.

Vickie Anderson was unanimously elected as Executive Director-Treasurer by the TN WMU Executive Board November 1, 2014. She assumed the role January 1, 2015. The Executive Director-Treasurer Search Committee included Chair Phyllis Cobb, Springfield; Vice-Chair Shelby Lord, Lenoir City; Frank Green, Sparta; Rhonda Poore, Kenton; and Delores Coffey, Morristown.

The Tennessee WMU Missionary House, officially named "Mary's House", is finished – built, furnished and decorated! Six years ago Tennessee Woman's Missionary Union took on the God sized task to build a missionary house on the grounds of the Missions Mobilization Center in Mt. Juliet to commemorate our 125th anniversary and to provide a place for larger missionary families to reside and rest during their stateside assignments. Together we raised over \$200,000 for building and furnishing the house and another \$100,000 to establish an endowment for the future care of the house. Over \$60,000 worth of services and items were also donated to build and furnish the house. We are very grateful for these gifts, as well as, for the many people who poured countless hours into making this dream become a reality. We broke ground on April 6, 2013; dedicated the house on November 1, 2015; held an open house on August 1, 2016; and will welcome the first missionary family in September 2016. To God be ALL the Glory!

Missions Get-Together and Connection were held on March 20-22, 2015 at the Gatlinburg Convention Center with a total attendance of 1,634. Jean Roberson, from Birmingham, Alabama was the keynote speaker for Missions Get-Together. Rachel Lovingood, from Hendersonville was the keynote speaker for Connection. The annual offering totaled \$9,035.03 with 90% designated to the 2013-14 Golden Offering for Tennessee Missions; 10% benefited Tennessee N Touch Endowment at the WMU Foundation. Through the event ministry project, participants brought items to support Baptist Collegiate Ministries across Tennessee by giving: \$4,464.83 in cash, checks and gift cards; 3,707 Pop Tarts/snack bars; 262 rolls of toilet paper; 458 other paper products; 340 office supplies; 366 packages of drink mix/tea; plus much more!

Vickie Anderson was installed as Executive Director-Treasurer during the Tennessee WMU annual session on March 21, 2015 at the Gatlinburg Convention Center. Bobby Turner from First Baptist Church, Lenoir City was elected for her fourth year as President. Other officers elected include: Recording Secretary, Susan Kellough from Newbern; and Vice Presidents: Kathy Neely, Greenback; Lynda Ryan, Hendersonville; and Linda Pratt, Somerville.

The 2014-15 State Acteens Advisory Panelists were Susanna Clouse, Caney Fork Baptist Church, Cookeville; Hannah Schussler, Ebenezer Baptist Church, Greenbrier; and Emily Bartlett, Caney Fork Baptist Church, Cookeville.

Currently there are 17 Christian Women's Job Corps and 8 Christian Men's Job Corps sites in Tennessee. The new state coordinator is Janice Carter from Jasper. Baptist Nursing Fellowship is currently without leadership and did not meet in 2014-15. There are fifteen nationally trained literacy missions workshop leaders who are equipping church and associational leaders to serve through literacy ministries: English as a second language, adult reading and writing, and tutoring children and youth.

Two TN WMU prayer-walking teams went to Italy in cooperation with the convention partnership. Colleen Richardson, from Livingston, led a team in October, 2014. A second team led by Ann Davenport and Carolyn Outland, both from Murfreesboro, went to Italy in August, 2015.

The goal for the 2014-15 Golden Offering for Tennessee Missions was \$1,650,000. The theme for the 2014 Week of Prayer for State Missions was “Wake Up!” based on Romans 13:11. As of July 31, the total amount given to the 2014-15 GOTM was \$1,595,802. The GOTM giving year is September 1 – August 31.

The year 2015 has been a milestone for the *Baptist & Reflector*, the official newsjournal of the Tennessee Baptist Convention. This year the *Baptist and Reflector* is celebrating its 180th anniversary. It began in 1835 as *THE BAPTIST*. The paper is one of the oldest newspapers in the Southern Baptist Convention.

The paper is mailed to nearly 25,000 homes 26 weeks a year, reaching a potential readership of about 63,000 people.

In addition, the *B&R* has become one of the top two most viewed pages on the Tennessee Baptist Convention's website at www.tnbaptist.org. With the shift to a biweekly format, the goal is to increase the *B&R*'s web presence. A new dedicated website for the *B&R* will be launched this year. It will replace the "virtual edition" and will make it much easier to share articles and columns. It will be "user friendly." The website will have new material added regularly and an update will be sent weekly to those who are used to receiving the "virtual edition." The virtual edition will no longer be published once the new website is ready for use.

The goal of the paper is to "tell the story of Tennessee Baptists" through news, feature stories and photographs. As in the past, the paper this year placed a major emphasis on what Tennessee Baptists are doing to reach the world for Christ by focusing on stories related to missions and evangelism. This year the paper has focused on timely topics for Tennessee Baptists and our churches. Issues have focused on addictions, issues related to same-sex marriage, and the Supreme Court decision in June and others.

The *Baptist and Reflector* continued to utilize social media tools in 2015 such as Twitter. Editor Lonnie Wilkey regularly writes a blog that provides information for Tennessee Baptists between print issues. The paper also will introduce a Facebook page this year.

The staff monitors trends that could affect Tennessee Baptists and prints those stories to keep readers informed. In addition, opinions, both from the editor and others, are printed and are intended to make readers think, reflect, and act.

The paper continually seeks to enlist new subscribers and will be offering a simplified subscription plan in the near future. Union University


The mission of Union University is to provide Christ-centered education that promotes excellence and character development in service to Church and society.

IMB Report Fall 2015

GOD IS WORTHY of the worship of all people, yet billions have yet to hear of Him. That's why we go. That's why we send to the growing global cities and the hard-to-access places. We go into a dark and broken world to share the only hope: the gospel of Jesus Christ.

IMB has been helping churches to participate in God's global mission since 1845. In the 21st century, we are equipping churches to send in new and creative ways. IMB exists to empower limitless missionary teams to make disciples and multiply churches among unreached peoples for the glory of God.

Redeemed and made new in Christ, we have a missionary identity that compels us to take the gospel even to difficult places and hard-to-reach peoples. In a beautiful partnership, IMB helps churches send ordinary Christians, empowered by God's extraordinary presence, to make disciples and multiply churches among unreached people for the glory of God.

Toward this end, last year Southern Baptists gave \$94.7 million through the Cooperative Program (\$94,736,418.32) and \$153 million (\$153,002,394.13) through the Lottie Moon Christmas Offering® for International Missions, supporting more than 4,700 missionaries sent out by Southern Baptist churches through IMB.



In addition, Southern Baptists gave \$6.6 million (\$6,556,271.02) for hunger relief and development ministries around the world.

Together, these gifts enabled IMB missionaries to report:

- **274,888 people professing faith in Christ**
- **190,957 new believers expressing their faith through baptism**
- **13,824 new churches planted**

And yet today, more than 6,000 people groups and 2.8 billion people have never heard the good news of the gospel and currently don't have access to this good news. God is sending church planters, professionals, students, retirees and others to major global cities, where millions of unreached people flock to seek better lives. We can give them hope in Christ.

He is also sending His followers to the extremes – deserts, jungles, war zones and other places that are hard to access because of culture, geography and tough living conditions.

As IMB mobilizes Christians and churches to join God's mission through evangelism, Bible translation, disaster relief, sustainable development and more, it is with one goal in mind: to make disciples and multiply churches in fulfillment of Christ's commission.

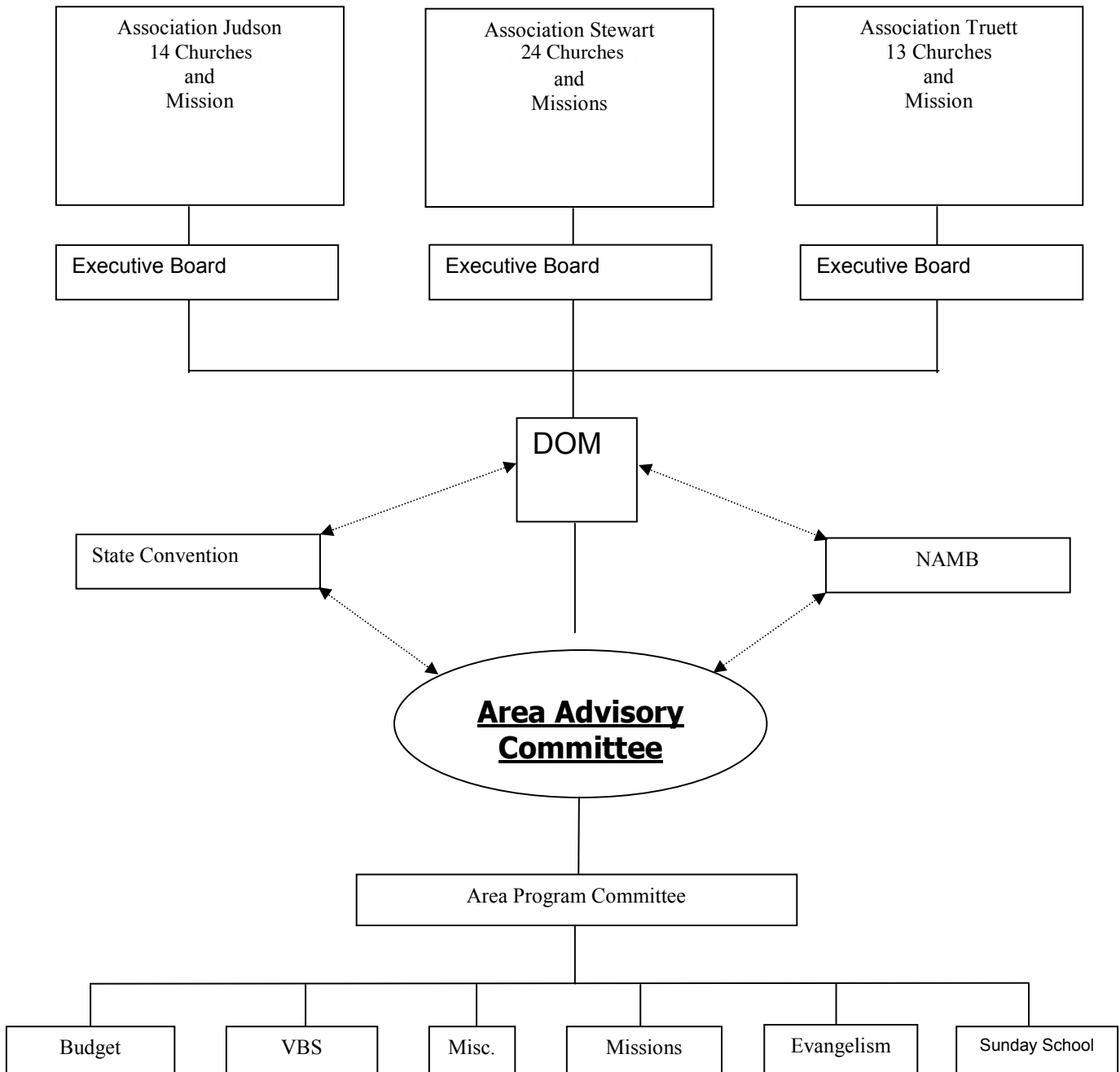
