Constitution

ARTICLE I - NAME

This Association shall be called the Truett Association of Missionary Baptist.

ARTICLE II - PURPOSE

1. To foster fellowship among the churches cooperating with the Association.
2. To assist the churches in strengthening their programs of enlistment, evangelism, teaching, and training.
3. To encourage churches in the establishment of missions and new churches.
4. To promote these programs of the Tennessee Baptist Convention and the Southern Baptist Convention as it may deem proper.

ARTICLE III - MEMBERSHIP

The Membership of this Association shall be composed of messengers elected by the churches with the Truett Association on the following basis.

1. Each church, regardless of size, may have three (3) messengers.
2. Each church may have one (1) additional messenger for each fifty (50) members or fraction thereof over 100 members.
3. No church may have over ten (10) messengers.
4. All pastors of the churches, officers of the Association and members of the standing committees shall be members of this Association. Churches may be admitted to membership in this Association by a two-thirds majority vote after a petitionary letter has been received by the Credentials Committee. and upon said committee's recommendation.

ARTICLE IV - OFFICERS

The officers of this Association shall be Moderator, Assistant Moderator, Clerk and Treasurer and any other officers that the Association may deem necessary in order to perform the work which needs to be done. The officers shall be elected on the first day of the Association's Annual Meeting, and their tour of duty will begin at the close of the Annual Session. The Moderator may not be eligible for election if he has served two or any part of two terms until at least a year has passed.

ARTICLE V - AUTHORITY

The Association claims no jurisdiction over the churches, and shall exercise no authority over them; however, it shall be the duty of the Association to offer fraternal council to any church in need of the same, upon their request. The Association will reserve the right to refuse to recognize messengers from any church which persists in disorderly practices.

ARTICLE VI - EXECUTIVE COMMITTEE

1. This Association shall have an Executive Board composed of the regular officers of the Association, and other elected officers, Pastors and Chairman of the Standing Committees, along with two elected laymen from each church.
2. This committee shall meet on the fourth Monday night, in October, January, April, July and August. (July shall be the planning meeting). November, January, March, May and June be given to promoting Sunday School, Discipleship Training, Brotherhood, W.M.U. and Stewardship. Only urgent business will be introduced at an emphasis meeting.

ARTICLE VII - PARLIAMENTARY PROCEDURE

1. The By-Laws may be added or the Constitution altered by a two-thirds majority of those present at any regular meeting of the Association. Said recommendations shall be presented to the Executive Committee at the meeting prior to the annual meeting.
2. Robert's Rule of Order shall be the governing procedure.

BY-LAWS

- I. One-half of all messengers attending the Association meeting shall constitute a quorum.
- II. Brethren not messengers of the Association and visiting Brethren invited to sit with the Association may be privileged to discuss but not the right to vote.
- III. The Nominating Committee shall make recommendations for all officers and committee members of Standing Committee.
- IV. The Moderator shall appoint any committees not otherwise provided for.
- V. The Moderator shall have the same privilege, as other members, provided he vacate the chair. While occupying the chair, he may vote only in case of a tie. These rules shall apply to the Assistant Moderator while he is occupying the chair.
- VI. The Association year closes August 31st. Church letters shall be in hand of Clerk by September 15th.

- VII. The Annual Association shall meet Thursday evening after the last Sunday in September.
- VIII. The Executive Board shall be the governing body of the Association between Annual Meetings and shall meet on the fourth Monday night of October, January, April and August with the Moderator given the authority to call special meetings of the Executive Board when needed, upon 7 days advance notice.
- IX. An Associational Calendar of events for the coming year shall be prepared and printed in minutes each year.
- X. All resolutions and reports shall be presented in writing, signed by person offering such report and shall become a part of the permanent record.
- XI. The Clerk and Treasurer shall be paid for services rendered by the amount set by the Budget and Finance Committee.
- XII. The following committees compose the standing committees of this Association
- 1) Promotion - All elected officers compose this committee and the Vice Moderator will serve as Chairman.
 - 2) Missions - This committee shall work with the Director of Missions in various projects in the Association, and shall be composed of five members.
 - 3) Budget and Finance - This committee will have two Pastors, Associational Treasurer and two other laymen.
 - 4) Program - This committee shall have three members, including Associational Clerk.
 - 5) Nominating - This committee shall nominate all officers, standing committees and fill any vacancies, which may occur. This committee shall be composed of five members.
 - 6) Credentials and Doctrine - This committee shall examine Credentials of new Churches and make the necessary recommendation after examination, and also counsel with any church when requested.
- Each committee shall make a report of the work accomplished and of the plans for the future to the Executive Committee at the four (4) Executive Board Committee meetings. Report of Committees to be made to the Executive Committee at the meeting prior to the Annual Associational Meeting.
- XIII. The Moderator shall be ex officio members of all committees, standing or special.
- XIV. The By-Laws may be amended or changed at any time by a majority vote of those present - Executive Committee or Annual Association.

**WORKING AGREEMENT
BETWEEN TRUETT ASSOCIATION OF MISSIONARY BAPTIST AND ASSOCIATION DIRECTOR OF MISSIONS**

- I. POSITION TITLE:** Association Director of Missions will be the official title, hereinafter called DOM of the Truett Association of Missionary Baptist, hereinafter called the Association.
- II. BASIC FUNCTION:** Provide leadership in the work of the Association in the interest of strengthening the cooperative Baptist witness throughout the area.
- III. QUALIFICATIONS:**
- 1) Personal dedication and consistent Christian living.
 - 2) A sense of call to mission service.
 - 3) Adequate educational preparation, preferably college and seminary training or the equivalent in experience and other training.
 - 4) Thorough knowledge of the work of a Southern Baptist Church.
 - 5) Knowledge of Association work from personal experience as a DOM or as a participating pastor or other Church leader.
 - 6) Reasonable knowledge of Southern Baptist denominational life and willingness to continue to learn.
 - 7) Ability to relate effectively to rural and small town Pastors and Churches.
- IV. RESPONSIBILITIES:**
- 4) Work with Association leaders and committees in planning and conducting activities designed to strengthen the churches according to their needs, and to maintain effective mission ministries in the area.
 - 5) Lead in planning and coordination of a calendar of Association activities to be presented each year to the annual meeting business session and printed in the minutes of the annual meeting as already provided for the By-Law number of the By-Laws Association.
 - 6) Lead in training Association organizational leaders and committees.
 - 7) Publish monthly a newsletter of the Association. The newsletter should contain news of interest, highlights of Executive Board action, treasurer's report, upcoming dates of Association activities, and other information and inspiration at the discretion of the DOM.
 - 8) Provide counsel and help as reasonably requested by Pastors and Churches.

- 9) Assist in stewardship development in order to undergird the work of the Association and encourage growth in the support of mission causes through the Cooperative Program.
- 10) Assist in maintaining a Biblical evangelism concern in the Association.
- 11) Serve as denomination contact person in the Association relaying quickly news of interest to churches by use of monthly newsletter, reports to the Executive Board, or other communication as considered appropriate by the DOM.
- 12) A report of DOM activities and concerns will be made at each Executive Board meeting and an annual report will be presented by the DOM to the Association Clerk for inclusion in the "Book of Reports" for the annual meeting. The DOM will report regularly to the Missions Department of the TBC.
- 13) The DOM will demonstrate true commitment to the purpose of Association as prescribed in Article II, "Purpose", of the Constitution of the Association.

V. CALL:

- 1) The call and employment of the DOM be by approval of the Association Executive Board. The Association Executive Board. The Association Missions Committee will serve as search committee when a vacancy of the position occurs and will recommend a nominee for the position to the Executive board.
- 2) The call of the DOM of the Association is a indefinite one. The position of DOM himself, or the Executive Board. The DOM will give the Executive Board thirty (30) days notice if resignation is desired; and the Executive Board will give the DOM sixty (60) days notice if the DOM's resignation is called for.
- 3) The amount of salary and allowances will be worked out and presented for approval annually. It is suggested that the Missions committee and the Budget and Finance committee work together when negotiating a pay package with the DOM.
- 4) Four (4) weeks per year will be allowed, off the field, for revivals, world mission conferences and other such activities. Consideration of the Association calendar is suggested when such activities are scheduled by the DOM.
- 5) The DOM will be allowed two weeks paid vacation each year, with three weeks after five years of service. Vacation time cannot accumulate one year to the next, and payment will not be made for time not taken. Consideration of Association activities is suggested in the scheduling of vacation time by the DOM.
- 6) One day of sick leave with pay shall accumulate for each month of service to a total of ninety (90) days. Sick leave is intended for use by the DOM in case of his illness or that of his immediate family that requires his attention or assistance, including funerals. Sick leave will be forfeited at the time of the DOM's resignation, or dismissal. The Association will not make payment for accumulated sick leave.
- 7) The DOM shall be entitled to receive and keep honorariums from revivals and from supply preaching when the church normally would provide and honorarium.
- 8) The work schedule may vary from week to week as need arises in the Association and Churches.
- 9) Due to the size of the Association and the rural setting of most of our Churches this agreement does not propose to regulate how many times the DOM can supply the pulpit, occasionally or successively in each Church, however, it is not intended that the DOM will serve any Church as interim Pastor, but rather assist as requested by the Church in securing pulpit supply so that DOM time and attention can be equitably shared with other churches and Association responsibilities. It is suggested that the DOM compile and maintain a current list of licensed and ordained ministers, and lay speaker in the Association that are available for supply work.
- 10) The employment of the DOM shall be considered full time.
- 11) The Association treasurer will be the payroll officer and the DOM will report to the treasurer when vacation time and sick leave is used, so a record of leave may be maintained.

VI. SUPERVISION:

- 1) The DOM will be basically "self supervised".
- 2) The Missions committee will serve as an advisory committee to the DOM in all matters pertaining to terms of employment and this agreement.
- 3) The Association Executive Board will direct the Missions committee and the DOM, and the Association will be the final authority pertaining to all matters of the agreement

VII. MISCELLANEOUS:

- 1) All other working agreements which have been made between this Association and other DOM's are null and void.
- 2) This agreement shall be recorded annually in the Association minutes and may be amended as necessary by the Executive Board or in the annual meetings. Two months notice should be given before amendments are made. The DOM will be informed in writing of any proposed amendments two months before action is taken.

September 29, 2016**

The 66th Annual Session of the Truett Baptist Association was held at Trace Creek Baptist Church, New Johnsonville.

Meeting opened with a song led by the host church, “God is so good.”

Bro. Mark Warren, pastor of Trace Creek, welcomed the congregation and led in a devotional from 1 Timothy about leaving a legacy. He explained that we need to be teaching others to follow behind us and be pointing others to Christ. We all should be training a disciple, training the disciple to make disciples, and make sure the disciples they are training are training others.

A congregational song, “He Leadeth Me,” was led by the host church followed by a special, “Be Thou My Vision.”

Meeting was called to order by the Moderator, Bro. Ken Brown, followed by a video from Dr. Randy Davis, Executive Director, TBC.

Tennessee Baptist Representative Bro. Archer Thorpe spoke about the vision of the TN Baptists to baptize 50,000 per year by 2024. He presented the Association a plaque for our Golden Offering for TN Missions giving.

Bro. Chris Allen from Southeastern Baptist Theological Seminary spoke about his work helping to train churches in theology through free theological classes or a certificate program geared toward helping churches go deeper into the Word.

The Summary of Executive Board Actions & Digest of Church Letters (page 10 & 11, Book of Reports) was presented by Mrs. Glee Smith, Associational Clerk, with one correction to be made. Bro. Reece Cochran made a motion to accept the reports as corrected, Bro. Mark Warren seconded the motion. Motion passed.

Bro. Neal Westerman, Chairman of Nominating Committee, presented the Nominating Committee Report (page 12, Book of Reports). Bro. David Deavers made a motion to accept as written, Bro. Dwayne Smith seconded the motion. Motion passed.

Bro. Neal Westerman, Chairman of Advisory Committee, presented the Advisory Committee report (page 12, Book of Reports) and shared changes to the Link-Up between the Associations due to Bro. Gray’s plans for retirement. Bro. Neal also spoke about changing the budget year for the Link-Up to run from January to December. Motion was made by Bro. E.G. Mullinax, seconded by Bro. Bill Lowe. Motion passed.

Bro. Ken Brown opened up the floor for any miscellaneous business. There was none.

Mrs. Carmen Westerman presented the Treasurer's Report and the Budget & Finance Committee Report (pages 16-18, Book of Reports). Bro. Reece Cochran made a motion to accept as presented. Seconded & passed. The proposed budget for 2016-2017 was submitted for approval (page 19, center column omitted, Books of Reports). Bro. David Devers made a motion to accept, seconded by Bro. Dwayne Smith. Motion passed.

Bro. William Gray, DOM, presented his Missionary Report and Calendar of Events and spoke of his 31 years of service as Director of Missions.

Bro. Joe Shannon spoke of the work they have done in Ecuador over the past 5 years and other ministry opportunities in our association.

Organizational Reports

WMU — Mrs. Carmen Westerman reported on the kick-off to the Golden Offering held at Waverly FBC. She also promoted WMU throughout the association and announced upcoming quilting events to make lap quilts for nursing homes. Trace Creek BC will host a luncheon for Home Mission in December. An International Missions study on Norway will be held at Sylvia BC in November. RA Camporee will be October 14-16 at Camp Linden. Connection & GetTogether for women & Acteens will be held March 31-April 2 in Gatlinburg. The theme will be "By All Means." The missionary kid, sponsored by Truett Association, is now a senior. All churches are encouraged to acknowledge her achievements throughout this year.

Mrs. Lee Lowe gave the Memorial Report honoring those in our churches who have passed away this year.

Bro. Ken Brown preached a message from 1 Peter 4:7-11 about how we should be about the Father's work and that we have a calling in this world.

After the sermon, Bro. Ken Brown asked for a motion to adjourn. Motion was made by Bro. Neal Westerman, seconded & passed.

Tennessee Baptist Adult Homes

The ministries of Tennessee Baptist Adult Homes continue to Show What Love Is to over 320 seniors and adults with intellectual disabilities by providing a loving, Christian home for them. If you were to visit any of our facilities, you would hear the residents offer their personal words of thanks and appreciation for your prayers and financial support. On their behalf, please accept my sincerest gratitude.

At our Baptist Health Care Center in Lenoir City we are providing 24/7 nursing care for about 70 senior adults who are in need of medical and physical care they are unable to provide for themselves. The love and compassion shown by our staff is an extension of God's love and represents the call of all Christians to care for the weak and the weary. In a quickly changing landscape and culture in the health care arena, Baptist Health Care Center has always remained true to its mission to provide a "home" for those in need. Please continue to pray for BHCC over the coming months and years. Pray that we may discern the will of God in our endeavors to provide care.

Adjacent to BHCC is a new development called Williams Ferry Pointe for seniors who are able to live alone but want to be in Christian community with other seniors. New homes are being built and purchased as the WFP community continues to grow. This homeowner's association enjoys a relationship with the adjacent Baptist Health Care Center should the need arise for more involved care.

Rounding out our ministry to seniors are two other independent living locations. Baptist Village in Johnson City has 4 duplex homes providing a home for 8 retired ministers and missionaries. And, Deer Lake Retirement Community in Nashville is a condominium community of 135 units for senior living.

Our group home ministry for adults with intellectual and developmental disabilities cares for 55 men and women in Nashville, Lebanon, Knoxville, and Jacksboro. The men and women in these homes need the love and compassion of dedicated staff who care for their physical and spiritual needs in these homes. These homes are answering the question that all parents of special needs adult children eventually ask, "Who is going to care for my son or daughter when I am no longer able?" Thank you, Tennessee Baptists, for answering in such a beautiful and meaningful way!

Finally, thank you for your gifts to the Golden Offering for Tennessee Missions that make Special Friends Camps possible. This year, 250 adults with intellectual and physical disabilities enjoyed a week of fun, fellowship, Bible study and worship at Carson Springs and Linden Valley. The families who care for these campers the other 51 weeks of the year enjoyed a week of respite, knowing that their loved one was with our caring, Christian camp staff. Tennessee Baptist Children's Homes

The Tennessee Baptist Children's Homes is celebrating its 125th birthday this year! On November 16, 1891 what would become TBCH took its first four children into care. We continue to be thankful and amazed at the work the Lord has done and continues to do through this ministry to children and their families.

At the end of 2015, Dr. Bryant Millsaps retired after 18 years of faithful service to the children. He continues to serve TBCH in a consulting relationship to the new president, Bro. Greg McCoy, who after having the opportunity to serve alongside Dr. Millsaps throughout 2015, assumed the position of President/Treasurer on January 1, 2016.

As a ministry that is now fully accredited by the Council on Accreditation, TBCH is continuing to strive for excellence in our residential and foster care programs.

As of this writing, TBCH has ministered to 204 different children in residential care this year. While many of these children still reside on one of our five campuses, 36 children have been successfully reunited with their families, and three children have been adopted and placed in a forever family! We have also assisted nine students with their post-secondary education.

TBCH's Foster Care Program has served 42 children and has had 55 Christian parents commit to be Foster Families. Several of these children are in "Foster to Adopt" situations that we are praying will result in more children having permanent homes. We are working hard and trusting the Lord to make sure the next time these children pack their suitcases; it will be for vacation rather than to move to another home!

We continue to rejoice as 19 of the children in our care have been born again while on our campuses or in one of our foster homes! Through the faithful service of our staff, the churches they attend, and by God's grace an eternal impact is being made on the lives of the children who come into the care of TBCH.

This great work would not be possible without the faithful support of the Tennessee Baptist Convention. Thank you for supporting the Cooperative Program and the vision of our Executive Director, Dr. Randy Davis. Thank you for promoting the Mother's Day Offering that directly blesses the kids. Many of you stepped it up in honor of our 125th anniversary! TBCH is thankful for the many churches, individuals and businesses who serve and share their resources with us all year long.

Finally, thank you for caring about children who find themselves in hard places. They need us. The Lord has commanded us to meet their needs. And with your help and His strength, we will obey.

Tennessee Woman's Missionary Union 2016 Annual Report

Tennessee Woman's Missionary Union encourages and equips churches and individuals to engage in missions learning and involvement that impacts spiritual lostness in Tennessee and around the world. The WMU emphasis for 2015-16 was "All For You – Surrender, Sacrifice, Serve" based on Mark 8:34.

Highlights from the past year include:

- The 2015-16 State Acteens Advisory Panelists were Hannah Schussler from Ebenezer Baptist Church in Greenbrier, Emily Bartlett from Caney Fork Baptist Church in Cookeville and Callie Simmons from Rocky Point Baptist Church in Morristown.
- The 2015 Week of Prayer for State Missions was September 13-20, 2015 and the theme was "Serve as You Have Been Served". The goal for the 2015-16 Golden Offering for Tennessee Missions was \$1,750,000. The total amount given to the 2015-16 GOTM was \$1,713,258. The total was a 5.3% increase over the previous year. In addition, 1,220 churches gave to the offering in 2015-16, a net increase of 44 churches over the previous year. The GOTM giving year is September 1 – August 31.
- A total of 194 women participated in the Women's Prayer Retreat on September 18-19, 2015 at West Jackson Baptist Church. "No Fear" was the event theme and featured speaker, Kimberly Sowell from South Carolina, blessed us with messages on "not a spirit of fear", "but of power", and "of love and self-control" based on 2 Timothy 1:7.
 - Over 2,000 toiletries, bed-n-bath, school supplies, books, sport items and clothing were collected and given to a local ministry, Eden of Youth Town.
 - An offering of \$1,132.61 was collected and given to Baptist Global Response to benefit the Syrian refugee crisis.
- October is always a busy time for children's missions events.
 - Over the three weekends of JAM, there were 677 participants, from 57 different churches from across Tennessee, with an additional 135 volunteers.
 - At RA Camp-O-Ree, there were 634 campers and adult leaders representing 39 churches, with over 100 additional adults serving as volunteers and missionaries who led and participated in different activities.
- In December, Tennessee WMU mailed, on behalf of Tennessee Baptists, Christmas checks:
 - Checks for \$150 to twenty-one missionary kids whose parents serve with IMB and are from Tennessee.
 - Checks for \$50 to eighty retired IMB missionaries who are from Tennessee.These gifts are made possible through an allocation from the Golden Offering for Tennessee Missions for nurturing Tennessee missionaries and their families.
- Missions Get-Together & Connection were held on April 8-10, 2016 at the Gatlinburg Convention Center with a total attendance of 1,710. Connie Cavanaugh from Canada was the keynote speaker for Missions Get-Together. Cindy Townsend from Mississippi was the keynote speaker for Connection.
 - The annual offering totaled \$9,444.40 with 90% designated to the 2017 MK Re-Entry Retreat that will be hosted by Tennessee WMU for the first time; 10% benefited Tennessee WMU Touch Tomorrow Today Endowment at the WMU Foundation.

- Through the event ministry project, participants brought items to benefit homeless shelters, developmental centers and other ministries across Tennessee that were distributed by TBC Compassion Ministries. Items collected and distributed: 6,554 pairs of socks, 4,885 underwear, 210 t-shirts, 57 bras and \$600 in monetary donations.
- Martha Pitts from Germantown Baptist Church was elected to her first term as President, during the Tennessee WMU annual session on April 8, 2016 at the Gatlinburg Convention Center, Other officers elected for 2016-17 include: Recording Secretary, Susan Kellough from Newbern; and Vice Presidents: Kathy Neely, Greenback; Yolanda Houser, Crossville; and Diane Sorrell, Covington.
- In April 2016, \$35,700 in scholarships were awarded to 31 students attending graduate school, seminary, as well as, undergraduate schools in Tennessee during the 2016-17 school year. These scholarships are funded through endowments, invested funds and the Golden Offering for Tennessee Missions.
- Currently there are 21 Christian Women's Job Corps and six Christian Men's Job Corps sites in Tennessee. This Christian based program, seeks to help men and women in breaking the cycle of poverty through job and life skills classes, Bible study and mentoring. In 2015, Tennessee sites served 1,727 participants and recorded 750 spiritual decisions which included 206 professions of faith.
- Four missionary families have been ministered to through the Tennessee Baptist Convention missionary houses.
 - Two families in Mary's House, the Tennessee WMU missionary house:
 - Scot & Jennifer T. from September 2015 -March 2016
 - Scott & Valerie Payne from May 2016 through December 2016
 - Two families in the Missions Mobilization Center (MMC) house:
 - Peter & Jennie Stillman from October 2015 - January 2016
 - Bob & Nancy Shirey from March 2016 through December 2016
- Seven Literacy Missions workshops were conducted this past year training 75 volunteers: four English as a Second Language workshops and one Adult Reading & Writing workshop. Statistically, for every one full workshop, where 25 volunteers are trained in how to start and lead an ESL ministry, one participant in the ministry is saved. These are usually international adults over the age of 18, one of the most difficult people groups and age range to reach. There are over 45 church and associational literacy missions ministry sites across the state.

The *Baptist and Reflector* continues to be the primary news source for Tennessee Baptists. The paper is mailed to more than 24,000 homes 26 weeks a year, reaching a potential readership of about 62,000 people.

The *B&R* has increased its web presence. A new dedicated website for the *B&R* was launched last year and it continues to be an effective way to bring Tennessee Baptist news to its reader in a timely manner. An e-newsletter was introduced this year to let Tennessee Baptist leaders know the latest news on the website.

The goal of the paper is to "tell the story of Tennessee Baptists" through news, feature stories and photographs. As in the past, the paper this year placed a major emphasis on what Tennessee Baptists are doing to reach the world for Christ by focusing on stories related to missions and evangelism. This year the paper has focused on timely topics for Tennessee Baptists and our churches.

The *Baptist and Reflector* continued to utilize social media tools in 2016 such as Twitter. Editor Lonnie Wilkey regularly writes a blog that provides information for Tennessee Baptists between print issues. The paper also introduced a Facebook page in 2016.

The staff monitors trends that could affect Tennessee Baptists and prints those stories to keep readers informed. In addition, opinions, both from the editor and others, are printed and are intended to make readers think, reflect, and act.

The paper continually seeks to enlist new subscribers and will be offering a simplified subscription plan in the near future. To fulfill this mission in accordance with our core values, Union developed and is now pursuing seven strategic themes in our new strategic plan, *United in Spirit. Grounded in Truth*. The plan's strategies and accompanying goals and activities will enable Union to pursue ongoing distinctiveness in its academic programs, constantly seeking after the ultimate embodiment of truth: Jesus Christ.

Among the highlights at Union University during the 2015-2016 academic year:

- We completed our first year of the EDGE program for students with intellectual and developmental disabilities.
- We added a 49-bell carillon to Miller Tower, thanks to a gift from the Opha Miller Trust.
- Hundreds of students participated in dozens of GO mission trips around the world.
- We hosted the West Tennessee Evangelism Rally in February, which drew over 800 people.
- Union graduate and Trustee Steve Gaines, Pastor of Bellevue Baptist Church, was elected president of the Southern Baptist Convention.
- We presented the Dodd Award for denominational service to Kevin Ezell, a Union alumnus and President of the North American Mission Board.
- Our student publication, the Cardinal & Cream, was named the best college magazine in the South for the second year in a row at the Southeastern Journalism Conference.
- Christian Universities Online named Union the top Christian university in the South.
- We received a grant, along with Lane College, from the Wabash Center for Teaching and Learning in Theology and Religion to promote collaboration in teaching and racial reconciliation.

IMB Report Fall 2016

Thank you for the way you have partnered together with us to get the gospel to people who have never heard it before.

Over the past year we have walked through difficult days at the IMB. But to see God's provision through churches and through the Southern Baptist Convention ecosystem has been amazing. From the way that you have cared for, encouraged, and supported missionaries who have made transitions, to the way you have redeployed many of them into your churches and your communities for the spread of the gospel here in North America, to how you have sacrificially and generously given through the Cooperative Program and the Lottie Moon Christmas Offering — it's nothing short of breathtaking to see well over \$260 million dollars given from churches with the express purpose of getting the gospel to people who have never heard it.

Toward this end, in 2015 Southern Baptists gave \$95.2 million through the Cooperative Program and \$165.8 million through the 2015 Lottie Moon Christmas Offering® for International Missions, the highest total in the 127-year history of the offering. These gifts support almost 4,000 missionaries sent out by Southern Baptist churches through IMB.



In addition, Southern Baptists gave \$6.5 million for hunger relief and development ministries around the world.

Together, these gifts enabled IMB missionaries to report:

- **127,385 people professing faith in Christ**
- **54,762 new believers expressing their faith through baptism**
- **3,842 new churches planted**
- **886 people groups engaged**

I hope that this ministry report is also a picture of what lies ahead as Southern Baptists move into the future. We pray the number of people who have come to Christ, the churches planted and the leaders trained will multiply in the days to come as we continue to pray, give, go and send for the glory of God. We want to partner together with you to take gospel to a world where 2.8 billion people have little or no access to the gospel.

IMB exists to empower limitless missionary teams to make disciples and multiply churches among unreached peoples for the glory of God. As IMB mobilizes Christians and churches to join God's mission through evangelism, Bible translation, disaster relief, sustainable development and more, it is with one goal in mind: to make disciples and multiply churches in fulfillment of Christ's commission.

Pray that God will create a missional awakening in our churches. Pray that He will wake up Southern Baptists to see His great glory and that churches will pray with zeal for the glory of God among the nations. Pray that churches will be aware of ways to give with even greater sacrifice for the glory of God among the nations. The Area Program Committee shall consist of two members from each association selected by the Nominating Committee of each association and elected at the Annual Business Meeting of each association. The initial Area Program Committee shall be elected by the Executive Board’s of each association.

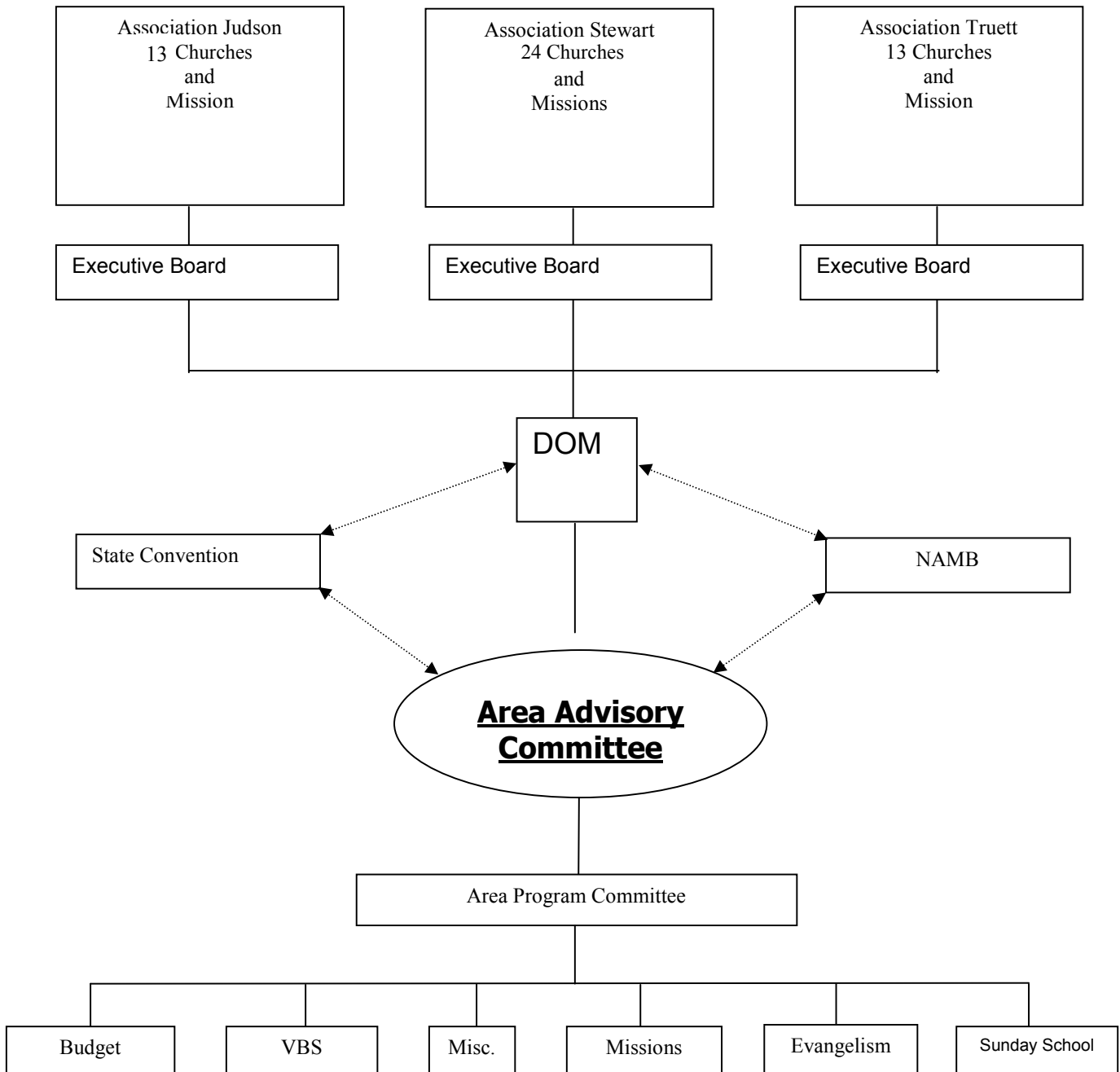
